BUFORD HWY/GA-20 W becomes VETERANS MEMORIAL BLVD. 0.8 mi  
Turn LEFT onto INDUSTRIAL PARK BLVD. 0.3 mi  
End at 209 Industrial Park Dr Cumming, GA 30040-2733

**GA 400 South**

Take the BALD RIDGE MARINA RD exit, EXIT 15, toward CUMMING. 0.3 mi  
Turn RIGHT onto BALD RIDGE RD/BALD RIDGE MARINA RD. 0.3 mi  
BALD RIDGE RD/BALD RIDGE MARINA RD becomes PIRKLE FERRY RD. 0.5 mi  
PIRKLE FERRY RD becomes E MAIN ST/GA-20 N/GA-9 N. 0.1 mi

Turn LEFT onto VETERANS MEMORIAL BLVD/E COURT HOUSE SQ/OLD BUFORD RD/GA-9. Continue to follow VETERANS MEMORIAL BLVD. 0.6 mi

Turn RIGHT onto INDUSTRIAL PARK BLVD. 0.3 mi  
End at 209 Industrial Park Dr Cumming, GA 30040-2733

GA-20 S. 12.7 mi  
Turn RIGHT onto VETERANS MEMORIAL BLVD. 0.5 mi  
Turn RIGHT onto INDUSTRIAL PARK BLVD. 0.3 mi
